I, (Name) _____ Agree for myself and (if applicable) for the members of my family to the following: 1. I agree to observe and obey all posted rules and warnings, and further agree to follow any written or oral instructions or directions given by UNIT 55, or the employees, representatives or agents of UNIT 55. 2. I recognize that there are certain inherent risks associated with the above-described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge UNIT 55, its owners, employees, representatives and/or agents, and the owners of 9922 E Montgomery Ave #33, Havgood Montgomery, and its agent Kiemle Hagood for injury that I may suffer in connection with or related to my participation in the Event, or any loss or damage arising out of my or my family's use of or presence upon facilities of UNIT 55, whether caused by fault of myself, my family, UNIT 55 or other parties. 3. I understand that as part of the Event I may be physically touched by certain employees, representatives and/or agents of UNIT 55 as part of the Interactive Entertainment and I hereby grant permission for such touching. In addition, I am aware that the Event will employ the use of flashing lights, strobe lights, tight spaces, colors, smoke, and smells. I agree that I will not touch or otherwise make purposeful physical contact with any employees, representatives and/or agents of UNIT 55. 5. I agree to indemnify and defend UNIT 55, its owners, employees, representatives, and agents against all claims, causes of action, damages, judgments, cost or expenses, including attorneys' fees and other litigation costs, which may in any way arise from my or my family's use or presence upon the facilities of UNIT 55 and/or in connection with or related to my participation in the Event. 6. I agree to pay for all damages to the facilities of UNIT 55 caused by my or my family's negligent, reckless, or willful actions. 7. Any legal or equitable claim that may arise from participation in the above shall be resolved under Washington law. 8. I agree and acknowledge that I am under no pressure or duress to sign this agreement and that I have been given a reasonable opportunity to review this agreement if I so desire. I further agree and acknowledge that I am free to have my own legal counsel review this agreement if I so desire. I further agree and acknowledge that UNIT 55 has offered to refund any fees I have paid to use its facilities if I choose not to sign this agreement. 9. This agreement and each of its terms are products of an arms' length negotiation between parties. In the event that any ambiguity is found to exist in the interpretation of this agreement, or any of its provisions, the parties, and each of them, explicitly reject the application of any legal or equitable rule of interpretation which lead to a construction either "for" or "against" a particular party based upon their status as the drafter of a specific term, language, or provision giving rise to such ambiguity. 10. The invalidity or unenforceability of any provision of this agreement, whether standing alone or as applied to particular occurrence or circumstances, shall not affect the validity or enforceability of any other provision of this agreement or of any other application of such provision, as the case may be, and such invalid or unenforceable provision shall be deemed not to be a part of this agreement. 11. By signing this release form, I authorize UNIT 55, to use the following personal information: 1) My picture – including photographic, motion picture, and electronic (video) images. 2) My voice – including sound and video recordings. I hereby grant to UNIT 55, its subsidiaries,

licensees, successors and assigns, the right to use, publish and reproduce, for all purposes, my name, picture of me in film and electronic (video) form, sound and video recordings of my voice, and printed electronic copy of the information described in sections (1) and (2) above in any and all media including without limitation, cable and broadcast television and the Internet, and for exhibition, distribution, promotion, advertising, sale, press conferences, meeting, hearings, educational conferences, and in brochures and other print media in connection with the advertisement and promotion of the Event and UNIT 55. This permission extends to all language, media, formats, and markets now known or hereafter devised. This permission shall continue forever unless I revoke the permission in writing. I further grant UNIT 55 all right, title, and interest that I may have in all finished pictures, negatives, reproductions, and copies of the original print, and further grant UNIT 55 the right to such materials for marketing, communications, or advertising purposes, as it deems fit. I hereby waive the right to receive any payment for signing this release and waive the right to receive any payment for UNIT 55's use of, or any rights to inspect or approve, finished photographs, audio, video, multimedia, or advertising and copy printed matter or computer generated scanned images and other electronic media that may be used in conjunction therewith or to approve the eventual use to which it might be applied. 12.
